

ORDINANCE NO. 1507

AN ORDINANCE OF THE CITY OF DES MOINES, WASHINGTON relating to revenue and finance, removing obsolete sections from chapter 3.48 DMMC, and repealing DMMC 3.48.010, 3.48.020, 3.48.040, 3.48.060, 3.48.080, 3.48.100, and 3.48.110.

WHEREAS, Title 3 DMMC, Revenue and Finance, contains outdated provisions, and

WHEREAS, the City Council desires to continue its process of updating the DMMC by repealing obsolete portions, and

WHEREAS, the City Council finds that this Ordinance is appropriate and necessary for the preservation of the public health and welfare; now therefore,

THE CITY COUNCIL OF THE CITY OF DES MOINES ORDAINS AS FOLLOWS:

Sec. 1. Repealed. DMMC 3.48.010 and section 19 of Ordinance No. 1144 creating an "airport defense fund" are hereby repealed.

Sec. 2. Repealed. DMMC 3.48.020 and section 20 of Ordinance No. 1144 creating an "arterial street fund" are hereby repealed.

Sec. 3. Repealed. DMMC 3.48.040 and section 22 of Ordinance No. 1144 creating a "community development block grant fund" are hereby repealed.

Sec. 4. Repealed. DMMC 3.48.060 and section 24 of Ordinance No. 1144 creating a "marina advance moorage deposit fund" are hereby repealed.

Sec. 5. Repealed. DMMC 3.48.080 and section 26 of Ordinance No. 1144 creating a "park fund" are hereby repealed.

Sec. 6. Repealed. DMMC 3.48.100 and section 28 of Ordinance No. 1144 creating a "revenue stabilization cumulative reserve fund" are hereby repealed.

Sec. 7. Repealed. DMMC 3.48.110 and section 29 of Ordinance No. 1144 creating a "senior services division enhancement trust fund" are hereby repealed.

Sec. 8. Severability - Construction.

(1) If a section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

(2) If the provisions of this ordinance are found to be inconsistent with the other provisions of the Des Moines Municipal Code, this ordinance is deemed to control.
